Tournament Rules

1. This tournament is certified by the USBC through the Gr. Kansas City, MO USBC Association (KCUSBC). Entry will be open to USBC Members. USBC Rules and regulations will govern this tournament.
2. This handicap tournament shall consist of a Two-player Mixed Team. Six consecutive games shall be bowled on your starting lanes. Total pins plus handicap shall decide the winner.
3. Baker Format consists of the gentleman bowler bowling on the odd lane all his turns and the lady bowler bowling on the even lane all her turns.
4. The teams average will be the combined two individual bowlers' highest book average of the previous two seasons (2016-17 and 2017-18), including summer averages of 21 or more games, divided by two. If a bowler does not have a previous two seasons book average (2016-17 and 2017-18), including summer averages of 21 or more games, then a current season's league average as of December 30, 2017 with at least 9 games will be used. All others will bowl scratch.
5. The handicap will be 90% of the difference between the teams' average and 225.
6. Bowlers may participate multiple times. A bowler can cash only once with the same partner.
7. No refund of entry fees can be made after reserve entries close, December 30, 2017.
8. Substitutes are allowed when replacement is necessary. The **tournament office** must be advised of substitution at least one hour before the scheduled bowling time.
9. Any player/team arriving after the squad has started will be allowed to bowl. Their score will be zero for all frames missed.
10. Entries will be scheduled in the order they are received. The schedules will not be changed except in case of emergency. Only team captains will be dealt with for scheduled change requests. The Tournament Manager reserves the right to cancel a squad for lack of entries.
11. Late entries are allowed, subject to availability of lanes, up to one hour before squad. Entries with payment received before the December 30th 2017 deadline will get squad choice and times over late entries.
12. Rule 319a/1, 3 & 5, 319b and 319c apply. Rule 319a/2 & 4, 319d, 319e and 319f will not apply. Rule 319a/2 is better known as the 10-pin rule.
13. The line-ups will be the gentleman bowler on the odd lane and the lady bowler on the even lane.
14. The Gr KCMO USBC, whose decisions are final, will decide all decisions over questions, not covered in the current USBC Rule Book.
15. Violation of USBC or tournament rules will result in disqualification.

16. All prize fees returned 100%. Ratio at least 1 out of 8.

The entrants whose names appear herein, or their authorized replacements hereby agree that KCUSBC shall be liable only to the extent of returning any unused entry fees, if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule changes, or premature termination of the tournament; which may be brought about by war, national emergency or emergencies of causes relating thereto or resulting there from fires, strikes, lockouts, labor difficulties or other causes beyond the control of the tournament manager.
